PRIVATE MEMBERS' MOTIONS

- 31/2025 To move that the Hon. Minister for Public Works and Transport within fourteen (14) days after passing of this Motion, submit a detailed report on the status of the Ministry's available plan and comprehensive Roads Maintenance Plan showing how the Ministry intends to maintain all the roads in the country. The report should include, amongst others:
- (a) A detailed Roads Maintenance Plan for the Financial Year 2025/26;
 - (b) A collated list of pieces of heavy plant and equipment required to effectively and efficiently maintain all the roads in the country. Whether untarred roads, main roads or district roads or feeder roads.
 - (c) The estimated cost of procuring new plant for the Ministry so that financing can be solicited for the procurement in the Supplementary Budget of the current Financial Year 2025/26.

The rationale behind fixing Eswatini's debt to GDP ratio at 40 percent, especially in light of the fact that the average debt to GDP ratio for the top 10 global economies is approximately 110 percent, and for the top 10 African economies, it stands at around 62 percent.

The Strategies that the Ministry of Finance in collaboration with the Ministry of Economic Planning and Development, is implementing to enhance the Infrastructure Development Index.

An explanation as to why the vital projects, including the 500km road network, the E2.4 billion housing project, and the FiFA approved stadium have not yet been constructed.

The Hon. Minister for Finance is hereby requested to table a comprehensive report on these matters within 14 days of the approval of this motion.
